# "Flat Rate" Billing and Invoicing Plan for 2024-2025 Season

In an effort to make the invoicing and billing for PPL and Company dancers more straightforward and understandable, we created 'Flat Rate' billing and invoicing.

As a Company and PPL dancer, each student will receive one pair of each discipline of shoes (ballet (one performance pair and one class pair), tap, jazz) and 5 pairs of tights (any color) for Showcase performances and Competitions. These are offered at no additional cost to you, and as a perk for being on PPL, therefore you will not receive a credit for any shoes or tights not used/taken during a season.

This document is to further explain the Flat Rate plan. As you register your child for our 2024-2025 Season, the registration form will total up your costs and give it to you before you submit registration.

# <u>TUITION –</u>

Students have a required amount of minimum classwork for each Pre Professional Level which is detailed in the Expectations Contract.

The price listed with the minimum classwork will cover tuition for these classes from September through May, *as well as* any costumes and accessories for these classes.

If the student wishes to add on additional electives, there is a 'per elective' charge, which also covers tuition for classes September through May and any costumes or accessories needed for the class.

## PPL DANCERS THAT ARE NOT ON COMPANY -

You are required to attend one convention per season. The total cost for this convention is \$351 for ages 6+, which for PPL dancers not on Company we will divide by 9 and invoice \$39 per month (payments each month from September through May).

## PPL SOLOS THAT WILL NOT COMPETE -

The cost for solos will be as listed below, and will cover class tuition as well as costume and accessories. All solos are one time per week.

30 minute solo - \$145 each month September through May

45 minute solo - \$197 each month September through May

60 minute solo - \$245 each month September through May

Example: A Junior level student takes the minimum level classwork with one additional elective, one convention, and a 30 minute solo:

- Minimum level classwork \$300 ea month
- One additional elective \$81 ea month
- One convention \$39 ea month
- 30 minute solo \$145 ea month

• Flat Rate Billing Total each month: \$565 This total covers all tuition, costumes, one convention, and dancer's solo, as well as dancer's shoes and tights for the season.

#### COMPANY DANCERS -

Just like PPL, you will have Tuition and Electives that will be invoiced for 9 months September through May (see TUITION paragraph above).

## All Company Dancer solos that compete will be invoiced -

All company dancers that started their solo in the Summer sessions of 2023 will be competing at 2 competitions (Hollywood Vibe St. Louis and Imagine).

Cost will cover tuition, costume, two competitions and invoiced for 9 months, September through May.

30 minute solo - \$175 45 minute solo - \$227 60 minute solo - \$275

# Then there will be items that are invoiced over 12 months (September through August) Conventions:

You are required to attend two conventions per season. This year those conventions will total \$684; we are attending Hollywood Vibe Des Moines and ASH Chicago, so the first is \$334 and the second is \$350. Divided by 12, and it equals \$57 per month.

## Company Rehearsals, Costumes, and Competitions:

For each company competition piece, the main costs are rehearsals, costumes, and competitions. You will be invoiced \$55/month per competition piece September 2024 through August 2025, which will cover rehearsals (including August and September Company Intensives), costume, and two competitions each season (\$90 per competition routine per dancer, per competition).

Any solo or group invited to compete at an additional competition will be invoiced separately for that.

Example: A Junior Level student takes minimum classwork, one additional elective, the required two conventions, is in 2 competition pieces, and takes/competes a 30 minute solo. <u>Costs over 9 months September through May</u>

- Minimum level classwork \$300 ea month
- One additional elective \$81 ea month
- 30 minute competition solo \$175
- Flat Rate Billing Total each month (September through May): \$556

Costs over 12 months September 2024 through August 2025

- Two conventions \$57 per month
- Two competition pieces (\$55 each) \$110 per month
- Flat Rate Billing Total each month: \$167 per month over 12 months, September through August

These two totals (\$556 for 9 months Sept – May and \$167 for 12 months September – August) cover all tuition, costumes, all conventions and competitions, dancer's solo, as well as dancer's shoes and tights for the season.
